Certain functions are understood to be essential, these include, but are not limited to: attendance, getting along with others, working a full shift and dealing with and working under stress. Any essential function of this class will be evaluated as necessary. Should an incumbent/ applicant be unable to perform the essential functions or requirements due to a disability as defined by The Americans with Disabilities Act (ADA), reasonable accommodation for the specific disability will be made for the incumbent/applicant when possible.*

**JOB OBJECTIVE:** This job consists of operating grass cutting equipment as well as other machinery to perform maintenance activities at county parks and recreational facilities.

**ESSENTIAL JOB FUNCTIONS:**

- I. Operates hand and tractor-mounted mowers and hand-held string trimmers to cut grass in areas around facilities; performs minor preventive maintenance on tractors and mowers; sharpens and replaces blades on mowers
2. Operates dump trucks and other vehicles
3. Mixes and applies chemical agents, including fertilizers, fungicides, herbicides, insecticides, and pesticides
4. Cleans rest rooms and picks up debris
5. Repairs and paints park benches and trash barrels; performs more building and plumbing maintenance
6. Operates light earth-moving equipment, including small backhoe, Bobcat, and front-end loader, as required for maintenance and development projects
7. Operates light and medium duty trucks with trailers to transport equipment, materials, and supplies to work sites, department facilities, and dumping areas
8. Reports department facility equipment and buildings needing repair to the foreman or director
9. Transports inmate crew members to assigned work sites and ensures all inmate crew members abide by the set rules put in place by the county or state correctional facility

**SECONDARY DUTIES AND RESPONSIBILITIES:**

- I. Performs other related duties as assigned by the Department Head

**SUPERVISORY RESPONSIBILITIES:** may be responsible for supervision of county inmate work crew

**REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES:**

- Some knowledge of maintenance requirements for light and medium duty trucks
- Skill in the operation of light and medium trucks and trailers
- Skill in the operation of hand tools
- Skill in the operation of hand and tractor mounted mowing equipment
- Ability to follow simple oral and written instructions
- Ability to perform manual labor in all weather conditions
- Ability to locate assigned work sites from instructions or maps
- Knowledge of all related safety procedures

*These knowledge, skills, and abilities are usually, although not always, acquired through at least one year of experience in the operation of light and medium duty trucks and trailers; OR any equivalent combination of experience and training which provides /he required knowledge, skills. And abilities. Equivalent combinations of education and experience will be considered*

**ADDITIONAL REQUIREMENT:** Must possess a valid Mississippi Driver's License before employment and maintain licensure for duration of employment in this position.
